CHAIR & CEO'S REPORT

We did not know, at the dawn of another year, that what would ensue would be our greatest test of resilience, innovation and strength of family. 2020 has been a year like no other. The COVID-19 pandemic has swept the globe, leaving havoc in its wake. At the time of writing, Papua New Guinea was experiencing its second wave of COVID-19 outbreak, putting immense pressure on an already struggling health system, with many health workers testing positive to the disease and hospitals scaling back services. We have entered 2021 in the firm understanding that now, more than ever, Australians and Papua New Guineans must stand side by side as we continue to confront our greatest challenge in decades.

In direct response to the pandemic, KTF established its Project Airborne initiative, supplying tens of thousands of pieces of Personal Protective Equipment to front line workers including community health workers, aid workers and teachers, as well as mass distributions of soap and sanitation products, water taps, buckets and tanks, and COVID-19 educational awareness to schools, health centres and communities. Project Airborne has directly targeted hundreds of communities across Oro, Central and New Ireland Provinces; and our education and awareness work has reached 17 Provinces and more than 120,000 people. Additionally, all KTF projects were "pivoted" to respond to the pandemic and have delivered COVID-19 education and awareness and protection measures to all staff, partners and beneficiaries. Our women's groups pivoted to making WHO-standard face masks and we have distributed these widely across the country.

Against the odds, our Kokoda and Balimo Colleges, and our new Motu Koita FODE Centre, managed to deliver a full academic program in 2020, despite multiple disruptions posed by states of emergencies and lock downs. Across the three Colleges, 71% of students completed a full academic year and sat their end of year national examinations, with most others completing at least a portion of the academic year. This is testament to the resilience and commitment of our academic and ancillary teams across the facilities as well as our program managers and coordinators who fought against the odds to ensure educational continuity under extreme pressures. Our graduates from the Colleges will now pursue further training in teaching and health work and are committed to serving in these roles across remote and rural PNG.

2020 required significant flexibility across our portfolio; during the early stages of the pandemic, some projects were paused due to funding shortages or the inability to deliver under our usual operating models as a consequence of international and domestic border closures and other COVID-19 restrictions. During this period, KTF relied on the Australian Government's critical

subsidies including JobKeeper, which served as a lifeline and enabled the organisation to continue its frontline response to the pandemic and work across education, health, equality and leadership.

KTF emerged strengthened from the height of the financial impact of the pandemic thanks to assistance from the Department of Foreign Affairs and Trade's ANCP Program, which continued to support and partner with the NGO sector to respond to the pandemic; and with our critical and generous long-term donors and partners, including the Sustainable Development Program, Mundango Abroad, and Web of Hope Foundation. As such, we were able to continue to roll-out support for schools and health facilities across remote and rural Oro and Central Provinces, including the operations of 14 health facilities and delivery of critical primary healthcare, child and maternal health services, vaccination patrols and health promotion activities. We were also able to commence new teacher training initiatives, pilot early childhood programs, and provide targeted resourcing, teacher training and coaching support for rural primary and elementary schools. We commenced a new gender-based violence and child protection initiative, supporting training, education and awareness in Oro Province as well as the operations for a newly established safe house for women and children fleeing violence - the first of its kind in Oro Province. As it enters 2021, thanks to the generosity of its existing and new supporters, KTF is well placed financially to further increase its assistance to the peoples of PNG.

Like the rest of the world, we learnt to operate in a new online environment, and introduced a strong technology element to the entire organisation including virtual connectivity of our offices and Colleges, delivery of training via e-learning mechanisms, and technology adaptations across every project. We hosted the second Pawa LikLik NGO Virtual Forum bringing together 160 people from Australian and international NGOs to share learnings and lessons on aid and development in the age of COVID-19.

Our Archer Leadership exchange also took place online in 2020; and whilst we eagerly await borders re-opening so that the 2020 cohort can complete their exchange to Australia, the exchange in 2021 will be replaced with a crossing of the Kokoda Track, connecting our most promising leaders with the spirit of Kokoda, the birthplace of KTF, and the leadership lessons that were etched into our souls almost 80 years ago, when Papua New Guineans and Australians came side by side to overcome great adversity. At the annual Lt. Col. Ralph Honner Leadership Oration, held virtually in October 2020, we were reminded by Sir Angus Houston AK of the criticality of relationships. Relationships built on trust, honesty and rapport are required for leading through times of hardship and adversity. We were reminded of the great leader that Ralph Honner was, who through his "courage, cheerfulness, calmness and skill" led the men of the 39th Battalion, against all the odds, to victory.

Just as we fought our greatest battles along the Kokoda Track side by side, we will only overcome

this present-day battle by working together. As we face this latest wave of the pandemic, we are committed to supporting our brothers and sisters in PNG through these dark hours. We are poised to play a critical role in the vaccine roll-out via our Healthy Communities project; and until that time, we are escalating our efforts to support our teams, partners and project beneficiaries to be in the strongest position of prevention and protection from the virus that is raging across the country. Our message is strong and simple. Wear face-masks at all times; double up where possible. Practice continuous hand-hygiene. Socially distance as much as possible, and isolate if you are sick.

2020 was a test of our resilience, but what shone more brightly than ever was the courage and culture of our extraordinary workforce – the staff, volunteers, directors and partners of the KTF. We thank every person who is a part of this special family – for your commitment, your endurance, your resilience and your positivity. We will need it in spades as we continue to fight the battles ahead.



PROTECTING PNG'S TEACHERS

A major educational reform is under way in Papua New Guinea involving a major re-structure of the schooling system and new requirements for PNG's elementary and primary teachers. In 2021, the new 3-6-6 structure of schooling officially came into effect. This means that the new structure is made up of Early Childhood education (3 years), Primary education (6 years) and Secondary education (6 years). All of PNG's teachers - existing and new are required to hold minimum Grade 12 schooling certificates as well as a minimum GPA of 2.4. This new policy has been applied in retrospect to all teachers resulting in the need for tens of thousands of teachers to re-train and up-skill.

One pathway for these teachers is to enrol in what is known as a second-chance education pathway or Flexible Open Distance Education (FODE). KTF's Kokoda and Balimo Colleges deliver this second chance education program and our target is



teachers and health workers who are desperately needed for remote and rural communities throughout PNG.

Via the Kokoda and Balimo Colleges, we support existing teachers to upgrade their qualifications so that they can remain in the teaching profession. We also support people who want to train as teachers and commit to running schools in rural areas to enrol in the second chance education pathway and in most cases create pathways for people who have dropped out of formal schooling many years ago but who are desperately needed for basic service provision in their communities.

Likewise, we support community health workers wanting to retrain as nurses or health officers; and we support people with a desire to train as health workers who often have already served their rural communities as village health volunteers. This critical pathway is the missing link in so many areas for the creation of a pipeline of people and professionals, desperately needed for PNG's rural education and health sectors.

Across the three FODE Colleges, we enrolled **471 STUDENTS**

71% OF STUDENTS completed a full academic year and sat for their end of year national examinations in October and November.



In 2020, against the odds, we opened the Motu Koita FODE Centre, bringing this second chance education pathway to the Motu Koita communities, the traditional landowners of Port Moresby. Our teams across the three Colleges have battled against the odds this year and managed to deliver a full academic program, despite multiple states of emergencies, border closures and lock downs.

Balancing studies, teaching and family can be a challenge, but Anna does it on a daily basis. At the age of 41, Anna is now in her final year studying Grade 12 at Kokoda College. She is also an elementary school teacher at Sengi Elementary School in her village at Kebara and juggles her teaching with FODE studies and taking care of her family.

Anna started her studies in 2019 by upgrading her Grade 10 marks, after an unexpected fail at Popondetta Secondary School in 1998, one of the pioneer students at the school. I thought that I was going to make it through, but unfortunately I didn't make it. I thought that I was going to be somebody in the future, but I didn't make it. I had failed."

Anna was determined to find a way to continue her studies.

She subsequently worked as a shop assistant in Popondetta town, married and had her first child. She was a stay-at-home-mum raising her children when she started elementary teacher training offered at Kokoda College, undertaking Certificate 1, Certificate 2 and then was one of 19 students graduating with her Diploma. Kokoda College's FODE program then provided the opportunity for Anna to upgrade her results to the level now required by the Department of Education to continue her journey to becoming a fully qualified teacher.

KTF supports Anna's role teaching Prep, Grades 1 and 2 at Sengi Elementary, a total of 84 students. She also walks four hours from her village to the college when she's studying, an eight hour round trip.

It is really challenging studying and teaching at the same time. After a long day of teaching, I get really tired, but it is my job and I have a duty to teach these children. At the end of a schooling day, I get exhausted and even hungry, but I have a very supportive husband and family." With Anna's positive attitude, she has come up with a workable weekday schedule; teaching until lunch time, planning classes from lunch till 4pm, preparing meals for her family in the evening and studying at night.

Every night and early hours of the morning, I take time to answer at least 10 to 20 questions from my FODE assignments. It is really challenging but I always know that with hard work comes good reward."

Anna looks forward to seeing the fruits of her labour at the end of 2021. "I hope that through my hard work, there will be a good result...I must do well in my studies so that I can improve and move onto the next level and be somebody in the future. I am hopeful."

I am very thankful for KTF. We are very privileged to have the full support of KTF. We have all the necessary materials needed for our FODE studies and also we are provided with accommodation and meals."

Anna wants to qualify as a teacher so she can also use her experience to encourage her children to do well in their studies. She wants her children to be one step ahead of her so that they can be "**somebody**" in the future.

SUPPORTING SCHOOLS: Teachers, resources and coaching

Teachers are, arguably, the most important contributor to student outcomes in Papua New Guinea; and must be supported to deliver effective schooling. Our work in supporting schools expanded in 2020 from the Oro and Central Provinces to include Western Province, thanks to our partnership with SDP. We know that by supporting teachers, investing in resources, and providing ongoing monitoring, coaching and mentoring, teachers and schools will thrive.

By focusing on three critical parts of high quality education-teacher training, targeted coaching, and holistic resourcing - the initiative aims to improve the quality of teaching and learning across remote classrooms. In 2020 we supported 36 schools and 147 teachers in Western Province; and a further 24 schools and 15 teachers in the Kokoda Track catchment region.

Our teachers receive regular professional development training in literacy and numeracy, junior primary teaching, standards based curriculum, teaching and learning strategies and many other areas.

Our core group of coaches, work directly in the schools with teachers every week, providing them with in-situ mentoring, guidance and support to

improve their teaching strategies and to brainstorm challenges as they arise. We augment this with the provision of critical teaching and learning resources including Bilum Books, Oxford University Press textbooks, PNG curriculum materials, tablets, TVs, library books and learning materials.





SCHOLARSHIPS & SUPPORT DURING COVID-19

Kokoda Initiative

In 2020, in partnership with the Kokoda Initiative and Kokoda Track Authority, we delivered a scholarship and schools support program to all communities along the Kokoda Track. More critical than ever, the scholarships eased the burdens for the families of 2,042 students; and provided schools with their annual project fees budgets so that they could ensure continuity of learning and school development during the pandemic.

The nine primary schools supported across the Kokoda Track catchment area undertook a range of

infrastructure works, maintenance, capacity building, resourcing and skills development activities. Projects included: building of new double classrooms, maintenance of facilities, libraries, toilet blocks, staff housing, teacher professional development and library resources including curriculum materials, reading books, and textbooks.

Pictured below is a new double classroom at Gorari Primary School from KTF's Scholarships Program in partnership with the Kokoda Initiative and KTA. The school used the 2020 project fees to construct the double classroom and provide much needed additional space for the hundreds of children enrolled at the school. KTF teams supported the scholarships and assisted the schools to co-design and co-deliver the major infrastructure project; whilst the scholarships eased the burdens of families during the economic crisis created by COVID-19.



Papua New Guinea is a country of 850 languages, the most linguistically diverse on the planet. With this diversity comes cultural differences created by relative isolation of a sparse population spread over a geographically challenging countryside.

A 'one-size-fits-all' approach is not always best in PNG, particularly for education. Although official languages are used in schools – English, Hiri Motu and Tok Pisin – cultural and linguistic differences mean learning is best tailored to local cultural and linguistic nuances. KTF's professional development projects for teacher upskilling are grounded in diversity, considering teacher skills base, teaching environment, available resources, geography and support accessible through provincial and national education bodies.

Teach for Tomorrow, the Early Years also works with Provincial Departments of Education to design and develop a new Early Childhood framework, curriculum and teacher training program specifically for that province with a goal of including children two to six years into the formal education system during critical formative years. This bespoke approach to education development brings the best possible learning outcomes for children in each province, setting them on their lifelong learning journey.

In 2020, KTF worked with 83 PROVINCIAL TRAINERS AND SENIOR TEACHERS across 5 PROVINCES.

In addition to the trainer and teacher skills development, KTF also established two bespoke ECE classroom infrastructure add-ons in Morobe and New Ireland Provinces, providing a bestpractice example of ECE classroom set ups and training paradigms. Together, these trainers are providing support to a cohort of **6,300 ELEMENTARY TEACHERS** who are responsible for establishing early learning classrooms in their schools from 2021 onwards.

Nagute Zaipo

Nagute Zaipo is KTF's Early Childhood Teacher Trainer responsible for rolling out our Early Years training across PNG. Nagute was trained as a primary teacher in PNG and in 2001 was handpicked to train as one of PNG's first elementary trainers; followed by a scholarship to undertake a Bachelor in Early Childhood in affiliation with University of South Australia and Divine World University. Immediately after,

Nagute joined the PNG Education Institution to train PNG's teachers at a critical juncture for PNG.

After a long and impressive career, in charge of curriculum and early learning with PNGEI, Nagute wasn't ready to retire and joined the KTF team. Having partnered with KTF on the Teach for Tomorrow roll-out, Nagute experienced first hand the organisation's commitment to the nation of PNG; not just a particular geographical region.

"It meant everything when I met KTF. So " many parts of PNG are crying out for help; especially in the remote areas. I still see that teachers are not trained well. I see they are only given instruction in English and this isn't working. I see KTF has respect for PNG's languages, cultures and resources. Across our nation there isn't enough respect for children's experience; play as a form of pedagogy or active learning has been over-looked and this must be central to the success for teachers."

Nagute is committed to ECE theories and practical implementation of theories in the classroom. "Conceptual, play curriculum and children learning via active learning - all the work KTF is doing - this has been missed elsewhere."

C Early Years has been really eye opening for communities. For the first time people are realising that early childhood education belongs to us. It is not reserved for others. It should be available to every 4 year old in the country and communities have the power to deliver this."

PROJECT AIRBORNE: Frontline Response to the COVID-19 Pandemic

With the COVID-19 pandemic spreading rapidly across the globe, KTF responded immediately and urgently with the design and delivery of Project Airborne. Project Airborne aims to prepare communities to deal with COVID-19 via education and awareness, WASH solutions, and health and hygiene methods including hand- washing, social distancing, mask wearing and healthy lifestyles. In 2020, Project Airborne worked with all KTF communities in the Kokoda Track catchment region across the Oro and Central Provinces, particularly focusing on schools, Colleges and health facilities. In 2021, KTF is preparing for a large-scale Project Airborne roll-out across New Ireland Province and ongoing support for the Oro and Central provinces and all of KTF's physical project locations across the country.

- 1. FACE-MASKS: wear a face mask at all times when you are outside of your home and around other people. Face masks should be WHO minimum standard masks which are at least three-layers. Masks should be well fitted; you can double loop the elastic to make them tighter. Doublemasking will also give you more protection in high-risk areas.
- 2. HAND HYGIENE: wash your hands regularly throughout the day. Hand washing should be with soap and water; or hand sanitiser. Do not touch your face or hair unless you have washed your hands.

- 3. DISTANCING: make sure you keep a minimum 1.5m gap between yourself and other people. Minimise your time around other people as much as possible.
- 4. ISOLATE IF SICK: if you have any cold and flu symptoms including sore throat, cough, shortness of breath, headache, body aches you should immediately be tested for COVID-19 (if testing is available near you) and isolate until you return a negative result. If there is no testing available, you and your immediate family should isolate for 14 days.



KEEPING HEALTH FACILITIES OPEN

Whilst significant efforts were made throughout 2020 to directly respond to the COVID-19 pandemic, it was equally critical that we kept our health facilities across remote and rural Oro and Central provinces operating. One of the major risks of the spread of COVID-19 is on the impact of health workers and facilities to continue doing their jobs: and delivering life-saving primary healthcare. PNG continues to face a range of health challenges including malaria, tuberculosis, maternal and infant mortality, diarrhoea, and pneumonia - all potentially life threatening issues. Our mandate was to ensure our health workers and their communities remained healthy and free from the virus, in order to keep health facilities operating.

KTF's Healthy Communities project provides access to primary healthcare for people living in remote, rural communities in Central and Oro Provinces. This project facilitates the operation of aid posts by supporting the salaries of CHWs and by providing drugs, medical equipment and infrastructure support. In 2020, we supported the operations of 15 health facilities across Oro and Central Provinces; delivering primary healthcare to a catchment population of 38,000 people. 3,780 children were immunised during the year and our health workers delivered 40 babies at their facilities.

CHWs perform a number of important roles for their communities. Primarily, they are responsible for the diagnosis and treatment of health conditions and obstetric care. Secondly, CHWs are responsible for carrying out vaccination patrols within their village and to surrounding villages that form the catchment area of the aid post. Vaccination patrols deliver childhood immunisations and also occur in response to disease outbreaks, such as polio. Finally, CHWs provide education for community members. For example, antenatal sessions are usually held on a weekly basis at the aid post. Other education seminars provided include communicable disease awareness, for example, HIV and TB, plus hygiene and disease prevention, child health, and dental care.

Preventing and containing the spread of the virus became a new focus of the PNG Healthy Communities project. Whilst it was vital to continue to provide resources and support health worker salaries during this health crisis, there was a need to expand the project to include the following:

- 1. COVID-19 Awareness campaigns;
- 2. Provisions of hygiene kits;
- Supply of Personal Protective Equipment (PPE);
- 4. Supply of COVID-19 related fever therapeutics.

Margaret Kombega joined KTF in 2018 as a community health worker at the Buna Health Centre in the Northern beaches of Oro Province. As the only female health worker at this facility, Maggie has become the specialist in

maternal and child health. Maggie is a new mother and has dedicated herself to reducing

maternal and infant mortality in her community.

Her duties as a community health worker include providing a range of primary health care services but she is also responsible for running weekly family planning clinics, prenatal clinics, delivering babies, and providing post natal care. During 2020, Maggie conducted awareness

programs for women in the Buna catchment on the importance of supervised births and prenatal care. Having pregnant women attend prenatal clinics is important as it follows that more women will present at the health centre to give birth. The numbers of women participating in these clinics has increased since Maggie's employment at Buna. From July to September 2020, she recorded 37 women attending prenatal clinics and this increased to 48 women from October to December 2020. The health centre has reported significant increases in

> the number of women presenting at the health centre to give birth, with 9 births reported between July and September and 6 births from October through December, 2020.

> Through her training, Maggie is able to manage complications associated with birth such as postpartum haemorrhage - which is a leading cause of maternal death. All of the women who gave birth at the health centre received postnatal care.

Maggie's work at the Buna health centre is vital as many women in PNG are not comfortable delivering babies in the presence of male health workers. She has made a huge impact on health outcomes for women and children in the Buna community.

In 2020, 196 students were enrolled in FODE studies at the Kokoda, Balimo and MKA Colleges who are interested in pursuing careers in HEALTH WORK. Of these, **138 STUDENTS** completed an entire academic year and sat their end of year exams. **53 STUDENTS** matriculated in early 2021 and are now seeking entry into health training programs in COMMUNITY HEALTH WORK OR NURSING.



STRONGIM MERI BISNIS / STRENGTHENING WOMEN IN BUSINESS

Strongim Meri Bisnis is working with women's groups in targeted communities to establish and support women-owned micro-businesses. The project aims to equip women from rural and remote locations with new business skills, equipment and supply chains providing them with an opportunity to generate an alternative income.

In 2020, the project had to pivot its approach and focus activities under the COVID-19 pressures of the year. With face masks made mandatory in schools, offices and public places early during the pandemic, the women identified an opportunity to respond. Given that they had already been set up with sewing machines and materials for the making of Pawa packs, it was an easy transition to making WHO compliant face masks to support PNG's COVID-19 response.

In 2020 the women made **2,500 FACE MASKS** and sold many of them to local communities and business houses. KTF's SMB pivoted project produces sustainable, clean and safe re-usable face masks based on the WHO standard three layered pattern using 100% cottons and calico fabric. This pattern is suitable for people living in rural communities to provide them some form of protective PPE face covering.





PROJECT ZERO

In a first-of-its-kind initiative for the Oro region, Project Zero is bringing together a vast array of stakeholders within formal and facilitated forums, to specifically address family and sexual violence, violence and women and girls, and child protection issues; and design and support community responses, schoolinterventions, and a public campaign.

Our key partners are Femili PNG, Family and Sexual Violence Action Committee, FSVU Popondetta and Embo Meni Pamone Oreka Bande Safe house in Oro. The partners are undertaking a suite of awareness activities with a wide consortia of stakeholders (including schools, health facilities, police and justice services, village courts, community leaders, women's groups), will deliver the FSVAC "Referral Pathways Processes 5-day training", will deliver FSVAC tool-kits to participating organisations and groups, will strengthen the capacity of FSVU-Popondetta in partnership with the Community Development division, and will support the operations and strengthen the capacity of the Embo Meni Pamone Oreka Bande safe house, the first and only wardlevel safe house in Oro Province.

As well as support services to women seeking refuge, the safe house is being supported with KTF's Strongim Meri Bisnis project, supporting women to establish livelihoods opportunities for when they leave the safe house.







LIGHTING UP PNG

To light up the lives of children across PNG, we are continuing to work closely with SolarBuddy – an Australian charity that seeks to eliminate energy poverty across the world. In 2020, we distributed 3,550 SolarBuddy lights across four Provinces, taking our total number of lights distributed to date to 36,000 lights since 2017.

Access to solar energy has a profound impact on lives and futures, as illustrated by our 2020 survey of recipients of student lights plus households that had solar systems installed as part of our Village Connect project in recent years.

ARCHER LEADERSHIP PROGRAM

In 2020, KTF's Archer Leadership Development Program entered its tenth year of finding and fostering the next generation of leaders for Papua New Guinea. The Archer Leadership Development Program is a yearlong bespoke program designed to challenge and grow individuals who are passionate about addressing some of PNG's greatest social issues. The Archer program is based on Harvard's Adaptive Leadership Theory and is made up of a number of leadership opportunities. The program develops the confidence, networks, skills, resources and support systems that the young leaders need to exercise exceptional leadership. Their year-long leadership journey as 'Archer Leaders' results in extraordinary young graduates, with lasting networks and the ability and willingness to create much needed change in PNG.

In 2020, the exchange program to Australia was disrupted by the global pandemic; and whilst we eagerly await the opening of borders, KTF designed a new immersion program, which was delivered via a combination of in-person experiences in Port Moresby and virtual connections. The immersion program sought to replicate many elements of the exchange program to Australia - difficult conversations, deep diving into Adaptive Leaders, meetings with key leaders from civil society, Government and private sectors, and leadership engagement within the group. The immersion program also involved visits to KTF projects in Port Moresby.

The 2020 cohort also undertook their community projects this year and a range of interesting ideas and initiatives emerged, including:

ARCHER REIGNITE

2020 saw KTF host the third Archer "Reignite" Conference in PNG; and launch the second Archer Reignite Grant. The Archer Alumni now comprises 66 young Papua New Guinean professionals who are committed to building a brighter future for the country. The Archer Reignite Conference provides a platform to inspire and harness the potential of these powerful young leaders. The opportunity cost of not doing so would be of significant detriment to PNG's future. To date, this group have proven that they have the capability to solve and challenge some of the most complex and challenging issues facing PNG with projects they have conceived, developed, implemented and maintained to benefit their communities.

Of course, part of the Alumni Conference in 2020 was held virtually and our speakers were a combination of physically present in the room and connected via Zoom.

The Archer Reignite grant was awarded to the Salamaua marketplace, an initiative of Jetta Caleb, Raylance Mesa, Joshua Sialis, Len Awinup and Jimmy Kiso, Alumni from 2011 to 2018. The team, including an architect, a social worker and an economist, were responsible for every step of the project from design to implementation.

The final result is a purpose-built space for women who travel far from the surrounding region to sell a range of goods they harvest and make, including





fish, market produce, clothing and bilums. It provides a safe location out of the tropical weather elements, generating income for the women and ultimately providing improved economic, health and education opportunities for their families. The marketplace was opened in February 2021. **"The marketplace means a lot to me** as a young leader contributing to the development of my community and a great relief to men and women who sell their produce without proper marketplace for a long time. The hardship of accessing a proper marketplace will be a thing of the past. It's a great relief that will improve the lives of many who depend on the market to earn income."

MONITORING, EVALUATION & LEARNING

2020 was a year of action in a year of immense challenges and uncertainty. Our commitment to sustainability and continuity, as well as the safety, health and security of our people, saw us end the year having fulfilled the majority of our intended organisational goals; albeit with major pivots towards directly responding to the COVID-19 pandemic and adapting our work to remain relevant and impactful under difficult circumstances.

Although our projects may have modified as 2020 unfolded, what didn't change is our commitment to

constantly monitoring and reviewing our programs to determine the effects and long-term impact of our programs in the communities where we work, in our quest to improve lives, livelihoods and futures.

As standard practice, we undertook a range of internal evaluation and learning exercises to assess program efficacy, identify refinements and strive for continuous improvement. With project expansion, we also improved our data capture processes to assist with this process, ensuring all practices reflect the remote environment in which we work, while using technology to the greatest benefit. We also took the opportunity to engage our corporate partner volunteers in converting our information for meaningful interpretation.





KTF aims to keep its fundraising and administration costs to a minimum. In 2020, KTF applied 84% of its total expenditure to the delivery of its International Development Programs in Education, Health, Livelihoods & Equality and Leadership, and 1% to disaster relief. Administration expenditure (6%) covers unavoidable, regulatory and administrative overheads as well as important investment in staff and management systems. Fundraising expenditure (9%) covers the costs of running KTF's events and appeals, upkeep of its website, and other marketing and communication activities.

As a public company limited by guarantee and a registered charity, KTF is required to comply with the regulations of the Australian Securities and Investments Commission (ASIC) and the Australian Charities and Not-for-Profits Commission (ACNC) Act 2012. This includes complying with Australian Accounting Standards and other mandatory professional reporting requirements. The Australian Taxation Office (ATO) has given KTF the status of a Deductible Gift Recipient (DGR) and a Public Benevolent Institution, granted exemption from Income Tax, and provided concession for Fringe Benefits Tax and GST. Reporting requirements comprise mainly annual fringe benefits tax returns, quarterly Business Activity Statements and monthly Pay-as-you-go (PAYG) submissions.

KTF undergoes an annual audit of its financial statements. 


