CHAIR & CEO'S REPORT

As we embark on another year, with uncertainty and many challenges ahead of us, we are reminded of our extraordinary family of dedicated people who are committed to keeping the spirit of Kokoda alive. From our extremely hardworking teams across PNG and Australia, to our army of volunteers, to our partners in delivery and fundraising, to our voluntary board and strategic advisors, the achievements of the organisation over this past year are for each and every one of you to be proud of.

Of course, the beginning of 2020 has been extremely difficult, from the bushfires that raged across Australia, devastating communities and wildlife; to the COVID-19 outbreak and the resulting health and economic crises that are unfolding around the world. We look to 2020 with a cautious lens and we will ensure that we balance a tightening economic climate with our commitments to our mission as well as the growing health impact that COVID-19 will have on remote communities across PNG.

But we also want to look back at the year that was and reflect on our impact and lessons learnt. 2019 was another year of growth, expansion, and scale-up of what we know works. We formally wrapped up our Teach for Tomorrow project which saw 3,685 elementary teachers trained across 14 Provinces, who together deliver schooling to more than 136,000 children across remote and rural PNG. These teachers comprise 54% females and 388 teachers with a disability. But certification is not our end goal; we are committed to the cycle of education and making sure that pathways are created for people into teaching careers, especially in remote and rural areas; and that once in those careers, teachers are supported and nurtured to deliver the highest quality teaching and learning possible. Our FODE program delivered across the Kokoda and Balimo Colleges, creates pathways for early school leavers in Oro. Central and Western Provinces to pursue second chance matriculation education and pathways into teaching and health work. At the time of writing, we are in the process of opening a third FODE Centre in Hanuabada, NCD, in partnership with the Motu Koita Assembly. Our Teach for Tomorrow II project is supporting the ongoing professional development and mentoring of thousands of teachers across eight Provinces; some of these teachers have not received prior professional learning since they originally trained, most over a decade ago.

Our work in health continues to evolve and respond to the major skills gaps identified by the health workers who deliver primary healthcare across the Oro and Central Provinces. 2019 saw the launch of our new Bebi na Mama project, which delivered specialised child and maternal health training to 105 community health workers and village birth attendants across two provinces. A new partnership with the Australian Council of Neo Natal Nurses, the training provides critical

knowledge and resources that health workers use to deliver and resuscitate babies, nurture mothers, infants and children, and save lives.

This year also saw the launch of a new livelihoods project: Strongim Meri Bisnis which delivers skills and business training to women's groups across New Ireland, Central and the Autonomous Region of Bougainville. The women create and sell reusable sanitary napkins. Our Village Connect project reached an extraordinary 1,000 households and 80 schools and health facilities, illuminating the entire Kokoda Track catchment region with sustainable and powerful solar lighting and charging systems. The results have been testament to the power of the intervention: a 92% reduction in expenditure of kerosene across the region and an increase in children's study time of 141%.

In October, we conducted a wide-scale qualitative review of the changes in education, health and wellbeing outcomes for communities along and around the Kokoda Track where much of our work has focused over the past 15 years. The results were promising with major positive outcomes reported across most communities including access to schooling and primary healthcare; but they also pointed to the future and where we must focus our efforts. The creation of pathways into formal learning and employment opportunities, especially in teaching and healthcare, were identified as of high importance across most communities.

In November, we launched our new Strategic Plan (2019 - 2022) which focuses on four core areas: (i) Improve lives and futures through education, health, livelihoods and leadership programs; (ii) Deliver programs via partnerships; (iii) Build the sustainability of the organisation; and (iv) Support a strong KTF.


We have set ambitious targets for ourselves over this next strategic cycle. By 2022, we want to reach half a million children and ensure they receive a quality education from the teachers that we help to support. We want to see 11,000 teachers receiving ongoing professional development and mentoring; including many who will be new to the teaching system. We want to increase the number people who have access to primary healthcare, especially vision and dental services; and we want to see 2,000 mothers with reliable access to pre and postnatal care delivered by our health workers who have been trained in specialised child and maternal health strategies. We want to see communities illuminated with the latest solar technology, people on pathways to formal education, women empowered and improved livelihoods, and to continue our work in finding and fostering the next generation of leaders for PNG.



Teachers are, arguably, the most important contributor to student outcomes in developing contexts. They are the life-blood of schools and need to be supported in order to build the quality of teaching and learning in schools.

In 2019, KTF formally wrapped-up its Teach for Tomorrow project, where in partnership with the National Department of Education and PNG Education Institute, KTF trained 3,685 elementary teachers across 14 Provinces. These teachers collectively deliver schooling to 136,000+ children across remote and rural PNG; 54% of teachers trained are women and 11% have a disability.

Teach for Tomorrow II supports the ongoing professional development and in-service training

for elementary teachers and was originally designed to ensure that teachers graduating from KTF's Teach for Tomorrow project, as well as existing teachers that were trained via Government and Church supported pathways, continue to receive ongoing professional development and in-service opportunities after they return to their teaching posts. With the change in structure of the PNG education system (to 1-6-6 schooling), KTF anticipated that a large skills gap would continue to grow between teachers trained under the old system versus teachers trained under the new system. As a result, via Teach for Tomorrow II, KTF developed a tailored professional development in-service program in partnership with Provincial Departments of Education to provide the upskilling support teachers required.

In 2019, KTF delivered targeted and intensive in-service to 112 provincial teacher trainers and senior teachers, including a professional learning exchange to Australia; taking the total number of trainers upskilled to date to 228. Together, these trainers are responsible for the development and in-service of more than 10,000 teachers across eight Provinces in PNG (New Ireland, Oro, Gulf, Morobe, Southern Highlands, Simbu, Hela, and the Autonomous Region of Bougainville).

Mary began training elementary teachers in 2004, after a previous career as an elementary teacher herself. Mary worked with KTF during the rollout of the Teach for Tomorrow teacher training program for 669 elementary teachers in her home province of the Southern Highlands. Throughout the training, participants had access to all materials, including Self-Instructional Unit (SIU) textbooks and stationery.

The teachers were also provided with communitybased accommodation during the training, as well as three-meals per day.

Mary reflected that over the training period, teachers significantly increased their competency in literacy and numeracy, as well as class sequencing, administration and assessment. Prior to the training, Mary noted that previous trainings were under-funded and lacked the necessary materials and resources, and also had to limit food rations to one or two meals per day, rather than three.

Many of the teachers that participated in the training felt that teaching was the only formal qualification available to them. If the participants did not become qualified teachers, they would be villagers and most likely would have no source of income.

Without KTF Mary said "the training would not have gone ahead" and expressed her gratitude

that the training was able to be conducted "without any hiccups". This allowed 669 teachers in her Province to be trained in a timely manner with access to all required financial and material support.

Whilst the teachers received a high-quality training program by KTF, Mary has received almost no professional development opportunities since a previous AusAID funded program in 2005. She also receives no financial compensation for the expenses she incurs visiting schools, and usually travels to schools via PMV with her own money.

In 2019, Mary joined the Teach for Tomorrow II program and participated in a suite of professional development and upskilling training programs including an exchange program to Australia. Mary visited a range of KTF's partners in Australia including Western Sydney University, Bundanoon Early Childhood Centre (Big Fat Smile), the Sydney Story Factory and the NSW Department of Education. She reflected:

I feel very happy. I feel so excited to learn. I want to know because I want

to learn more and to feed my students back in the school. These workshops are very important to me because I have learnt so many new things to go back and train my poor teacher back at my district for implementation in the elementary classrooms."

CREATING PATHWAYS INTO TEACHING

As well as supporting and strengthening PNG's existing cohort of teachers, KTF invests in the creation of pathways for people into teaching careers. There are major shortages of teachers across PNG especially in remote and rural locations.

PNG's Free Education Policy introduced in 2012 saw many children returning to school; and without a matching investment in teachers, this has resulted in overcrowded classrooms and high teacher: student ratios.

New minimum entry requirements also mean that the pool from which to draw people into pre-service teaching studies is smaller than ever; and as a result, KTF strongly believes that early school leavers with a commitment to teaching and remaining in rural areas must be given the opportunity to re-engage with formal education pathways.

KTF's Kokoda and Balimo Colleges deliver the FODE Program (Flexible Open Distance Education) to 230 students. In 2019, 80% of students sat for their end of year examinations; our gender breakdown across the two Colleges was 50% females and 50% males.

As we are focused on creating pathways for people in very remote and often disadvantaged areas, many of our students come from extremely challenging backgrounds and circumstances. A high proportion of students are orphans or come from single-parent households; many are parents themselves and struggle to balance work and other incomegeneration activities with their studies; and 16% of students report having a disability. Many students have to travel long distances each term to access the Campuses from remote Oro, Central and Western Provinces, demonstrating an enormously high dedication to their studies.

The students are all on pathways to becoming teachers and health workers once they complete

their matriculation studies and graduate with minimum Grade 12 GPAs. 60% of the students enrolled across the College are on pathways to teaching whilst 40% are on pathways to become health workers.

Helen, mother to three children (11, six and three years old) and pregnant with her fourth, was studying to upgrade her Grade 10 qualification during 2019. Such is her commitment to her education and hopes of becoming a

teacher, she gave birth to a healthy baby boy on the weekend and went straight to Balimo College to sit her National Examinations on Monday.

Helen lives in Kania village, a six-hour dinghy ride from Balimo and would not be able to study to fulfil her teaching dream if not for the support of her husband, extended family, the team at Balimo College and the flexible nature of the FODE course programming.

> During the two weeks of term Helen attends classes, she boards with her sister who lives in walking distance to the college and her infant son is cared for by relatives living adjacent to the College. Her very supportive husband cares for their three elder children at home in Kania. He wants Helen to complete Grade 12 so she can pursue her teaching qualifications

and works a range of carpentry and mechanical jobs to cover any costs associated with her tuition and dinghy fares to and from Balimo.

Helen is enjoying her second chance at matriculating, having previously studied Grade 10 in 2004. At the time, she struggled understanding lesson content and lacked the material and teaching support to successfully complete her study. In stark contrast, under the FODE program she has the time and resources to diligently apply herself to her studies, including all course content at her fingertips electronically on a tablet. She finds the teachers and staff at Balimo College very supportive and accommodating to student needs, especially mothers with young babies. Now studying Grade 11, Helen finds the course content she learned in 2019 has prepared her well for the year ahead.

Helen aspires to become a school teacher when she matriculates Grade 12 in 2021. She has witnessed the shortage of teachers in her village, with class overcrowding to ensure children have access to learning. She wants to help end the chronic teacher shortage that exists in her village and across PNG.

A post-script to this story is a true testament to how grateful Helen feels for the opportunity to study at Balimo College. In the ultimate compliment, Helen's youngest son is called Mudi, named after Principal, Mr Duwaba.





KEEPING SCHOOLS OPEN

Accessing quality education is an ongoing challenge for parents in PNG. KTF is committed to establishing and improving school infrastructure, supporting the development and posting of quality personnel, and providing school grants that provide supplies, key resources and help schools to remain open across remote areas. Specifically, KTF works to provide teachers with professional development and mentoring opportunities, provides resources and educational supplies to schools to enable their operations, builds educational infrastructure, supports teacher remuneration and works with schools to establish small social enterprises from which they can earn an income to further support the operations of the school. In 2019, KTF supported the operations of 35 schools across the Kokoda Track catchment region including 15 full-time teacher postings. 12 schools were supported with critical infrastructure and buildings maintenance and 2 schools received water supply infrastructure. Together these schools deliver teaching and learning to 3,875 children.

2019 also saw the roll-out of a new partnership between KTF and KTA which supported scholarships for 1,846 children to attend primary school along and around the Kokoda Track. Twelve schools were identified through the partnership to receive the scholarships support, relieving the large financial burden for parents across the region who struggle to pay schools fees and providing schools with funding for school operations, teacher development, leadership and management development and infrastructure improvements.

"This is the first time for such funding to be given to our whole school. The parents and teachers are very happy and will help children to concentrate on their school work. The funds are being used to purchase a chainsaw which will be used to mill timber and build a permanent house and support a volunteer teacher who is not been paid for some time." (Manari Primary School)

HEALTH

ADDRESSING CHILD & MATERNAL HEALTH



The Sustainable Development Goals are focused on ending preventable deaths and improving outcomes for mothers, babies and children. Targets by 2035 include decreasing all countries' newborn deaths and stillbirths to 10 or less per 1,000 total births and that no country should have a maternal mortality ratio greater than 140 per 100,000 total births. Current reported mortality rates for Papua New Guinea are estimated as: under-5 mortality ratio of 63 deaths per 1,000 births, infant mortality of 48 deaths per 1,000 births, and maternal mortality of 215 per 100,000. Although this data is thought to be under-reported.

In 2019, KTF launched its new Bebi na Mama project which aims to improve outcomes for newborns, their mothers and families across remote and rural PNG. We do this by providing targeted training and upskilling for community health workers, village health volunteers and village birth attendants across remote and rural regions. In 2019, in partnership with the Australian College of Neonatal Nurses, and Oro and Central Provincial Health Authorities, KTF delivered the training to 106 health workers across two Provinces. 120 neonatal resuscitation kits were provided to the health workers and training focused on resuscitation skills, kangaroo care, complicated deliveries, the importance of breastfeeding, and infant and child nutrition and general care.



I gained so much knowledge there to help the people in the remote communities. Another thing, during childbirth, we were taught to turn the baby upside down and tap the bum and make the baby cry – we thought this was normal way to do. But recently at the training we learnt that this was not right; instead, rub the baby at the back and stimulate it to cry. I was also taught the importance of the suction. In remote areas, most mothers give birth at home and the babies inhale the mothers waste. In these places it's very, very hard. I was given and taught how to use the penguin flask to suck the inhaled blood and mucus content and how to resuscitate the baby. I believe I am well equipped with the knowledge that was gained at KTF's training to save the life of babies. It is so difficult for us to transfer patients from Naduri down to Port Moresby – it's very expensive. But now I have the skills so that anytime I have such incidents, I believe that we will do the best we can do to save the mother and the child."

Leonie Vanua

Leonie is a community health worker who works at the health centre in Kupiano, Central Province. Leonie attended KTF's Bebi na Mama training where she received vital skills training as well as equipment, including a newborn resuscitation mask and a penguin suction device.

One month after the project was delivered, a mother presented to her facility in labour and after a long, difficult labour and birth the baby was born not breathing.

C The baby was born flat with the cord around the neck...I placed the baby on the mother's chest and I used the penguin and removed a lot of mucus."

With the use of the suction device, Leonie was able to clear the airways to allow the baby to breathe. Both the mother and the baby recovered well and were discharged from the health facility later that afternoon.

The simple, inexpensive and reusable suction device has had a huge impact in this remote community.

C I recommend more of these workshops be done to help our people. They are saving our mothers' and babies' lives".

GIVING THE GIFT OF SIGHT

Vision impairment is both a cause and consequence of poverty. There is a high prevalence of blindness and vision impairment in PNG, especially in remote areas where access to health services are limited. Our Eye See PNG and Sight for PNG projects support training and upskilling of health workers and health volunteers in eye health and eye care; as well as innovative and efficient refractive error testing that will be taken to scale across remote and rural PNG. Accompanying the testing is the provision of affordable prescription



spectacles to those who require them within the majority subsistence population.

We recently trained 30 Community Health Workers and Village Health Volunteers across Morobe Province; and undertook vision testing and glasses provision with more than 400 people in Hanuabada, NCD. Our testing technology was refined throughout 2019 to respond better to the context of delivery across remote and rural PNG.



KEEPING COMMUNITIES HEALTHY

Approximately 80% of PNG's population lives in rural and remote areas. Access to health services is extremely limited in many of these locations. where people often face the hardship of walking hours to seek medical treatment. KTF's Healthy Communities project provides access to primary healthcare for people living in remote, rural communities across the Central and Oro Provinces. This project facilitates the operation of twelve health facilities across the Kokoda Track catchment region by supporting the training, postings, mentoring and professional development of community health workers (CHW) and by providing resources and infrastructure support. Without KTF's intervention, the communities where we operate would face the hardship of travelling hours to seek medical care and in the case of many communities in the northern beaches region of Oro, there would be no access to healthcare.

The resources provided to aid posts via this project include life-saving drugs such as antibiotics, anti-malarials and analgesics. These reflect the most commonly presenting cases of respiratory infections, skin infections, malaria, asthma, and eye and ear problems. Other vital resources include first aid items, antiseptics, and medical equipment including stethoscopes and blood pressure monitors. Infrastructure including building materials, water tanks and solar cells are provided where necessary. In 2019, CHWs performed a number of vital roles for their communities. Primarily, they were responsible for the diagnosis and treatment of health conditions and obstetric care. 30 babies were delivered safely under the supervision of health workers in rural aid posts and over 100 more were delivered safely at the



Kokoda hospital. Secondly, CHWs are responsible for carrying out vaccination patrols within their village and to surrounding villages that form the catchment area of the aid post. Vaccination patrols deliver childhood immunisations and also occur in response to disease outbreaks, such as polio. Maintaining vaccination rates is vital to prevent future disease outbreaks. Finally, CHWs provide education for community members. For example, antenatal sessions were held on a weekly basis at most aid posts. Other education seminars provided include HIV awareness, tuberculosis awareness, hygiene and disease prevention, child health, and dental care and support for people experiencing domestic and other violence, especially women and girls. Community education is vital in combating the spread of communicable diseases.

STRONGIM MERI BISNIS / STRENGTHENING WOMEN IN BUSINESS

Strongim Meri Bisnis supports the establishment of microbusinesses with women's groups across remote and rural PNG. The project provides training and mentoring, capacity building, and start-up capital for women to establish successful solar, female hygiene and other business enterprises.

In 2019 new women's groups were established focussed on the creation of sanitary products. These women's groups were supported with start-up capital, skills and business training and literacy classes. The groups then created and sold 450 sanitary packs for

women and girls in rural and remote PNG. KTF delivered 20 workshops across its women's groups, covering female hygiene product technical training and business skills to new women's groups, and ongoing training and support of existing women's groups. Four women's groups have reinvested into their businesses, creating a sustainable model of operating.



We are so privileged that Petra has chosen Gabagaba to be part of this project which is the sewing of the sanitary pads. This product, in terms of hygiene, that's the most important thing, because the one we buy at the shops pollutes the whole environment and it's not good at all. Thanks to KTF for introducing these reusable napkins which can we reuse for 3 to 4 years and it's affordable for the ordinary ladies."(Women's Group Leader, Gabagaba)

CONNECTING HOUSEHOLDS AND COMMUNITIES

KTF's Village Connect project provides household solar lighting and energy systems to rural and remote communities throughout PNG. With improved power and energy solutions comes opportunities for villagers to engage in businesses and access communications, technology and other opportunities that improve the livelihoods of PNG people. For the first time, households in remote and rural areas have access to light throughout and outside their homes and an energy station to charge mobile phones and other simple appliances. The project reduces reliance on toxic kerosene and dangerous campfires simply for a source of light.

In 2019, we completed the connections of all households, schools, health facilities and community centres across the Kokoda Track catchment region, taking the total number of households illuminated to 1,000 and number of facilities illuminated to 75.

I don't spend money on kerosene anymore. Kerosene no more, I don't use them no more. Before solar lights we had to use kerosene and use torch light and now that the light has come we forget about the torch. It has saved me a lot of money."



LIGHTING UP PNG

To light up the lives of children across PNG, we are working closely with SolarBuddy – an Australian charity that seeks to eliminate energy poverty across the world. In 2019, we distributed 14,000 SolarBuddy lights across 11 Provinces, taking our total number of lights distributed to date to 30,000 lights.

LEADERSHIP



ARCHER LEADERSHIP PROGRAM

The Archer Leadership Program is finding and fostering the next generation of leaders for PNG. Based on Harvard's Adaptive Leadership and designed and delivered by KTF, the year-long program saw eight impressive final year university students complete leadership workshops, a 12 month mentoring program and an exchange trip to Australia where they met with individuals and organisations tackling some of Australia's and PNG's toughest social challenges. The leadership program has inspired me in more ways than one. It has inspired me to be a better version of myself with the hope of being a better inspiration to others. Also, it has inspired me to take a more proactive role is bringing positive influence and impact into my community and country. The leadership program helped me to identify the leadership opportunity; the gap between my aspirations and the current reality. This helped me to understand and realize that to bridge that gap between my aspirations and the current reality, I have to exercise leadership."

During the two weeks exchange trip to Australia, we visited several NGOs that are at the front line of addressing social issues in Australia. One of them was Street University, a youth center in Liverpool. I was really amazed and inspired by how it is set up and operated to help young people. It gave me hope that no matter what the social problems and challenges that people may face, regardless of whether they are in first world or third world country, there is always a way, an idea or an approach to help address those issues. Hence, that gave me hope for PNG. There is more that we can do. We just haven't tried yet."

ARCHER REIGNITE

2019 saw KTF host its second Archer "Reignite" Conference in PNG; and launch the Archer reignite grant. The Archer Alumni comprises 58 young Papua New Guinean professionals who are committed to building a brighter future for the country. The Archer Reignite Conference provides a platform to inspire and harness the potential of these powerful young leaders. The opportunity cost of not doing so would be of significant detriment to PNG's future. To date, this group have proven that they have the capability to solve and challenge some of the most complex and challenging issues facing PNG with projects they have conceived, developed, implemented and maintained to benefit their communities.

The Reignite grants were also launched in 2019 and the first collaboration grant awarded - the Salamaua

Women's Marketplace in Morobe Province. In remote Morobe Province, women have to carry their fresh produce for hours and sometimes days to reach their local marketplace. This purpose built marketplace will provide women with a safe place to sell their produce and to access clean drinking water and solar energy. The group of Archer Alumni working together on this project include an Accountant, IT specialist and an Architect.

MONITORING, EVALUATION & LEARNING

In our quest to improve lives and futures, we are constantly monitoring and reviewing our programs to determine the effects and long-term impact of our programs in the communities where we work. During 2019, we undertook a range of internal and independent evaluation and learning exercises to assess program efficacy, identify refinements and strive for continuous improvement.

We crossed the iconic Kokoda Track, capturing the experiences of people and communities along and around the Track to provide an insight into the changes in education, health and outcomes experienced and to identify their future needs. Overall, the report identified that there have been improvements in a range of education, health, infrastructure and livelihoods outcomes for the communities along and around the Track over the past 5 years and highlighted areas of future focus.

We commissioned an independent evaluation on Teach for Tomorrow, one of our most significant education projects undertaken to date, to provide an interim report on outcomes. The report evaluates its impact on teachers as well impacts observed by other key stakeholder groups, including trainers, provincial education staff, and representatives of the PNG Education Institute.





The forum featured a range of speakers from international development, government and corporate supporters (including long time suporters Perpetual and Mundango Abroad), openly and honestly sharing a broad spectrum of thoughts and ideas for development and growth. It is set to become an annual event.

The spirit of Kokoda was evident at the 16th Lt. Col. Ralph Honner Gala Dinner in Sydney, commemorating the great sacrifices made by the Australian and Papua New Guinean soldiers and beloved 'Fuzzy Wuzzy Angels' during the battles of Kokoda in World War II, with special tribute to the leadership of Lt. Col. Ralph Honner, commander of the 39th Battalion.

Hosted by Channel 7 News presenter, journalist, and KTF Ambassador, Michael Usher, this year's event was, sadly, the final special reunion of five surviving veterans of the Kokoda campaign - Arnold Forrester, Bill Ryan, Dick Payten, Reg Chard, and Lloyd Birdsall. It was fitting that Arnie said the ode, whilst Bill, an active environmentalist still fighting for his beliefs, was painted by renowned PNG artist Jeffrey Feeger.

An incredible array of speakers took the stage: KTF Chairman Ian Kemish AM delivered the Leadership Oration; CEO Dr Genevieve Nelson updated on our expanding work and achievements; Minister for International Development and the Pacific, Alex Hawke gave an insight into our countries' friendship today and in the future; and an extraordinary Q&A panel, including PNG's High Commissioner John Kali, Archer Leaders Stephannie Kirriwom and Raylance Mesa and visiting educators from the remote provinces of Hela and Gulf, Joanne Puname and Gabriel Opa, painted a vivid picture of, and insight into, their beautiful homeland, culture and people.



KTF aims to keep its fundraising and administration costs to a minimum. In 2019, KTF applied 83% of its total expenditure to the delivery of its International Development Programs in Education, Health, Livelihoods and Leadership. Administration expenditure (7%) covers unavoidable, regulatory and administrative overheads as well as important investment in staff and management systems. Fundraising expenditure (11%) covers the costs of running KTF's events and appeals, upkeep of its website, and other marketing and communication activities.


